NOTIFICATION

Regarding affiliation of students of Veda Bhushan and Veda Vibhushan courses in financially aided Veda Pathshalas/financially aided Guru-Shishya Parampara Units under Maharshi Sandipani Rashtriya Veda Vidya Pratishthan to Maharshi Sandipani Rashtriya Veda-Sanskrit Shiksha Board.

The 45th Governing Council meeting of the Pratishthan was held on 02-01-2023 under the Chairmanship of the Hon'ble Minister of Education and Chairman of the Pratishthan. The Hon'ble Chairman desired that in order to propagate and disseminate the ancient knowledge and art contained in the Vedas and to provide the Veda students with employment-oriented education, it is imperative for the Veda students in the financially aided Veda Pathshalas/ financially aided GSP Units of the Pratishthan to have knowledge of Temple-Rituals, Stotra-Path, Vastu, Astrology etc. along with complete memorization and correct pronunciation in Veda recitation.

With this purpose in view, the students of Veda Bhushan/Veda Vibhushan courses in financially aided Veda Pathshalas/financially aided Guru-Shishya Parampara Units/ Rashtriya Adarsh Veda Vidyalayas across the country under Maharshi Sandipani Rashtriya Veda Vidya Pratishthan are taught subjects of modern technical knowledge, knowledge of science, skill development along with Veda Mool Samhita to make Veda education more employment-oriented.

In terms of the approval of the Ministry of Education, Government of India, affiliation is mandatory for the students in Veda Pathshalas /Units/ Rashtriya Adarsh Veda Vidyalayas financially assisted by the Pratishthan for recognition of their examination of Veda-Bhushan and Veda-Vibhushan. In this regard, it was decided by the Maharshi Sandipani Rashtriya Veda Sanskrit Shiksha Board in its first meeting to charge annual fees for affiliation from the financially aided Veda Pathshalas/ financially aided Guru Shishya Parampara Units at the following rates:-
