## Circular - 1510

### Sub:- Absence of Students in Annual Examination-Reg.

Maharshi Sandipani Rashtriya Veda Vidya Pratishthan, Ujjain provides scholarship to the aided Veda students studying in financially assisted Veda Pathshalas and Guru Shishya Parampara Units of the Pratishthan. Scholarship of Rs. 3500/- per month per student is paid into the Institution/Veda teacher's account as maintenance scholarship and Rs. 1500/- is released into the students' account for personal expenses. Thus, over the course of a year, an amount of Rs. 60,000/- is paid to each financially aided student, based on the student's attendance as reported by the Institution/Veda Guru.

It has been observed from the data of the Annual Examination for the year 2023-24, that quite a good number of students were not present in the annual examination, despite their full attendance during the academic year. This gives the impression that either the student is not interested in studying Vedas or the Institution/Guru did not take timely action to ensure the presence of the student in the examination.

Therefore, the Institutions/teachers of the financially assisted Veda Pathshalas and Guru Shishya Parampara Units are hereby directed to take prompt cognizance of this fact and immediately inform the Dealing Assistant/ Assistant Director concerned in the Pratishthan regarding the details of the students who were absent in the annual examination so that scholarship amounts in respect of these absentee students in future can be stopped and the scholarship amount already paid during the year is recovered from the future grants to be released to the Institutions/Veda Gurus.
