

The undersigned is directed to refer to the subject mentioned above and to say that Maharshi Sandipani Rashtriya Ved Vidya Pratisthan (MSRVVP) has set up a Board in the name "Maharshi Sandipani Rashtriya Veda Sanskrit Shiksha Board (MSRVSSB)" under Rule 14(iv)(f) of the Rules under the MOA of MSRVVP. Department of School Education and Literacy, in consultation with NCERT, have concurred with the various Bye-laws and Statutory requirements for the Board.
