OFFICE MEMORANDUM - | 2.5 2

The Government of India provides stipend of Rs. 3500/- per month per student to the management of the Veda Pathashalas towards maintenance cost of the aided Veda students in the financially assisted Veda Pathashalas under the MSRVVP. The stipend amount includes cost of provision for satvik food (breakfast, lunch, afternoon snacks and dinner), accommodation and clothing of the students. Instructions have been issued by the Pratishthan to all Veda Pathashalas to constitute Food Committees for overseeing and monitoring quality of food being served to the students in Veda Pathashalas which are financially assisted by MSRVVP.

Surprise video inspections conducted by the Pratishthan at several Veda Pathashalas/GSP Units have revealed that quality of food and accommodation being provided by the Management of the several Veda Pathashalas/GSP Units is not satisfactory and not commensurate with the financial assistance per student being provided by the Government/MSRVVP. It is observed that the Food Committees in these Pathashalas have shown lack of sincerity and commitment and have virtually failed in its assigned duties in checking the quality as well as quantity of food being served to the students. Every day the respective Food Committee must check the quality and quantity of food and certify on the vouchers for purchases of grocery, vegetables, milk etc.

It is, therefore, brought to the notice of the management of the Veda Pathashalas in general and the Food Committees in particular to look into the aspect of proper utilization of the stipend amount on the students for the purposes for which they are sanctioned. For the purpose of providing general guidelines, the following standard approach, with minor changes as per local conditions and seasons, may be adopted by the Food Committees to ensure quality improvement in the food and accommodation arrangements in the Veda Vidyalayas.

FOOD

Breakfast	Poha, Upma, Halwa, Dalia, Idli, Dosa, Pongol, Poori-sabzi, Roti-sabzi, Namkeen chawal, Boiled chana, Boiled Mung etc.
Lunch:	Chawal, Roti, Dal and two seasonal green vegetables, salad and curd/butter-milk etc.
Afternoon snack:	Seasonal fruits, roti/sandwich, roasted peanuts/chana etc
Dinner:	Chawal, Roti, Dal and two seasonal green vegetables, salad etc. and milk (200ml) (The list is only illustrative and not exhaustive)

Quantities of each item should be sufficient for a growing child. Particularly, dal (preferably masur (lentil), mung & toor) should be at least 40 grams per head per serving and two vegetables 200 grams each per head per serving. It will be responsibility of the respective Food Committee to monitor and ensure the above standard. The members of the Food Committee as well as the Management of the Pathashala will be held responsible, jointly and severally for any slip up in this regard.

ACCOMMODATION & CLOTHING

The students should not be exposed to any extreme climate without proper clothing and bedding. Preferably wooden cots may be provided to each student. Dhurries, woolen blankets and warm clothing, apart from routine clothing must be provided to each student in winter season. This will be the responsibility primarily of the Management of the Veda Pathashalas as well as of the Veda teachers.

Surprise inspections will be conducted from time to time as per the orders of the Governing Council. Failure to ensure proper facilities and ideal settings for Veda studies of the students will make the Pathashalas/GSP Units liable to forfeit the financial assistance from MSRVVP.

As far as the GSP Units are concerned, all the above conditions are applicable except the constitution of the Food Committee and the respective Veda Gurus of the Units will be treated as the Management.

This is brought to the notice of all the Managements of Veda Pathashalas/ Units and all the teachers through this notification for necessary action and compliance.
