### NOTIFICATION - 1181

**Subject:— Setting up of Maharshi Sandipani Rashtriya Veda Sanskrit Shiksha Board by MSRVVP and vesting the authority for X and XII Board Examination and Certification by the Govt. of India and AIU in the Maharshi Sandipani Rashtriya Veda Sanskrit Shiksha Board/महर्षि सान्दीपनि राष्ट्रीय वेद संस्कृत शिक्षा बोर्ड (in Hindi)/ महर्षि सान्दीपनि राष्ट्रिय-वेद-संस्कृत-शिक्षा-परिषत् (in Sanskrit) established under the control of Maharshi Sandipani Rashtriya Veda Vidya Pratishthan for the purposes of the Bye-laws of the Board.**

1. The Government of India vide MHRD Resolution No. F. 6-3/85- SK-IV dated 30<sup>th</sup> March 1987 constituted a Society, namely Rashtriya Veda Vidya Pratishthan with the objective to preserve, conserve and develop the oral tradition of Vedic studies for which the Pratishthan has been undertaking various activities, such as supporting traditional Vedic institutions and scholars, providing fellowships/ scholarships, running Pathashala-s, Guru-Shishya Parampara Units, their examinations like Veda Bhushan, Veda Vibhushan, imparting training in Vedic recitation, conducting training courses for Veda Guru, promotion of Veda research activities etc. The Pratishthan has been registered under the Societies Registration Act, 1860 (XXI of 1860) No.S-17451 of 1987 with MoA and Rules. Later the name of the Rashtriya Veda Vidya Pratishthan Society was changed to Maharshi Sandipani Rashtriya Veda Vidya Pratishthan (MSRVVP) vide MHRD notification No. F. 6-21/92-skt-2 dated 24.12.1993, published in the Gazette of India, Part- I, Section – I, adding the name of Maharshi Sandipani, who pioneered his Gurukul in Ujjayini and taught all Vedic Knowledge to divine personality Shri Krishna along with Balarama and Sudama.
2. The General Body, being the policy making authority on Vedic education and Governing Council, being the principal executive authority of the Pratishthan, in their meetings held on 27.02.2019 and 15-5-2019 under the Chairmanship of Hon'ble Minister of Human Resource Development and Chairman of MSRVVP, have decided to constitute and set up Maharshi Sandipani Rashtriya Veda Sanskrit Shiksha Board (MSRVSSB) with its bye-laws under Rule 14(iv) (f) of the Rules of the MSRVVP. This has been confirmed in the Governing Council meeting held on 17-1-2020 and has been approved by the Ministry of Education, Govt. of India.
3. The Ministry of Education, Govt of India being the nodal Ministry for the educational policy formulation, direction and implementation, have been implementing the recommendations of various commissions and committees on Sanskrit/Veda education like Sanskrit Commission 1956-57, Vision and Roadmap for the Development of Sanskrit-Ten year perspective Plan- 2015-16 etc. The promotion of Vedic education was mandated at paragraph 18.7.3 in Programme of Action (PoA) -1992 of MHRD and was entrusted upon MSRVVP. The PoA was an outcome of deliberations of various



committees and consensus through CABE, conferences of Education Ministers of States, Secretaries and Directors of Education, as noted in the "Introduction to PoA-1992". It was also noted in the "Introduction to PoA" that "The POA, 1992 has to be perceived as charter for action of the nation as a whole". Therefore, the Ministry of Education, Govt. of India, being the controlling authority for Vedic education, has approved the decision of the General Body and Governing Council of MSRVVP for establishing the Board keeping in view the larger interest of Vedic education in the country.


4. The Department of School Education and Literacy, Ministry of Education, Govt. of India, vide notification in Gazette of India Part-I, Section 1, F No.11-3/2016-Sch 3 dated 15<sup>th</sup> November 2021, has conferred the power upon the Association of Indian Universities (AIU) for granting equivalence to courses/certificates awarded by various Boards and Universities.
5. The Department of Higher Education has made effective consultation with the Department of School Education and Literacy/NCERT/CBSE on the Bye-laws of MSRVSSB, affiliation regulation, examination regulation, course curriculum and have obtained concurrence of all the above departments for formation of MSRVSSB. The syllabus and the course curriculum have been vetted by NCERT and bye-laws have been vetted by CBSE. The said bye-laws contain all essential provisions for adherence to the National Curriculum Framework, National Education Policy and RTE Act (Bye-law Clause No.22), adherence to the NCTE prescribed qualifications for modern subject teachers (Clause No.23), and connecting the Skill to Vedic subjects and Vedic education (Clause No. 17.1), maintenance of quality (Clause No.30) and adherence to the directions of Govt. of India (Clause No.31). It shall be mandatory to the Board to adhere to the directions of Ministry, norms prescribed by NCERT on curriculum and instructions of AIU on all matters of equivalence.
6. The AIU through their letter AIU/EV/IN(I)2022/MSRVSSB dated 3<sup>rd</sup> August 2022 has granted equivalence to Examinations/Qualifications/ Courses of MSRVSSB with 10 and 12 Board/ Secondary and Sr. Secondary level Examination/Qualification/Course of Central/State School Boards of India for admission in higher education institutions/ courses and also for employment purposes.
7. In exercise of powers as per paragraph 4 above, (i) Association of Indian Universities vide letter AIU/EV/IN(I)2022/MSRVSSB/ 391 dated 3.8.2022, (ii) MSRVVP's nodal Ministry. The Ministry of Education, Government of India vide Office Memorandum No.3-14/2018-skt I dated 8.8.2022 and (iii) All India Council for Technical Education (AICTE) vide Circular AICTE/P&AP/Misc./2022/ dated 13.09.2022, have given recognition for setting up of MSRVSSB and granted equivalence of Grade 10<sup>th</sup> and 12<sup>th</sup> Board Examination/ Qualification/ Courses conducted by MSRVSSB, Ujjain, with Examination / Qualification / Courses conducted by other Central / State School Boards of India for the purpose of admission in higher education institutions and also for employment in Central / State Governments.
8. In pursuance of the Ministry's OM, AIU's letter dated 3.8.2022, and in pursuance of Rule 14 (iv) (f) of MSRVVP read with III chapter of the bye-laws, clause 14 and 15 of Maharshi Sandipani Rashtriya Veda Sanskrit Shiksha Board, the Board stands authorized for standardization, examination, affiliation, recognition, certification, authentication of

syllabi and programs on Oral Tradition of Vedas, Pathashala System of Traditional Veda or Sanskrit Education, allied subjects, blending the Veda-Sanskrit Education with modern knowledge and oriental type of education in the academic domain area in the whole country up to pre-degree level/senior secondary level as comparable to and recognizable in modern education set up/Examination / Qualification / Courses conducted by other Central / State School Boards of India in consonance with NEP-2020/Education Policy and the structural guidelines of NCERT on the syllabus and course curriculum, in addition to Veda and the model bye-laws of MSRVSSB for higher education and employment purpose and for the matters connected therewith or incidental thereto and/ or to do such acts ancillary to the objects of the Board as may be necessary. The Board shall also be the certifying authority for such other courses/other examinations as per the Bye-laws.

9. As per the para 1 (e) of the approved Bye-laws of the Board, the Maharshi Sandipani Rashtriya Veda Sanskrit Shiksha Board stands empowered for standardization, examination, affiliation, recognition, certification as comparable in modern education set up like 10<sup>th</sup> and 12<sup>th</sup> Board Examination/ Qualification/ Courses for authentication, framing of syllabi and course content, programs, to award certificates etc. in the domain academic area as per bye-laws of the Board.
10. As per the approved Bye-laws of the Board, para 1 (f) the Board came into force on the issuance of Office Memorandum dated 8-8-2022 by the Ministry of Education vide Office Memorandum No.3-14/2018-skt I dated 8.8.2022.
11. Henceforth, all examinations being conducted by Maharshi Sandipani Rashtriya Veda Vidya Pratishthan and any other examinations in the equivalent Grade of 10<sup>th</sup> and 12<sup>th</sup> Board Examination/ Qualification/ Courses as per bye-laws in the domain academic area will be conducted by Maharshi Sandipani Rashtriya Veda Sanskrit Shiksha Board (MSRVSSB) from the academic session – 2022-23.
